This disclosure constitutes your Truth In Savings Disclosure for your Webster Bank Savings Account and contains the terms and conditions governing your Webster Bank Savings Account. You have entered into a Webster Bank Deposit Account Agreement, and this Webster Bank Savings Account is one of the accounts that is subject to your Webster Bank Deposit Account Agreement.

Rate Information

As of the date of your account application, the interest rate on your account is 4.402% with an annual percentage yield of 4.50%. The interest rate on your account is a variable interest rate, and the annual percentage yield may change. At our discretion, we may change the interest rate on your account at any time.

Compounding and Crediting

Interest will be compounded on a daily basis and interest will be credited to your account each statement cycle.

Effect of Closing Your Account

If you close the account before accrued interest is credited, you will receive the accrued interest through the date of closure. If your account is unfunded or has a zero balance for more than 20 days, we may deem your account closed.

Minimum Balance Required to Open Account

You must deposit at least \$5,000.00 to open this account.

Minimum Balance Required to Avoid Monthly Balance Fee

There is no minimum balance required to avoid a monthly balance fee.

Minimum Balance Required to Obtain the Annual Percentage Yield Disclosed

You must maintain a minimum collected balance of \$25 in the account each day to obtain the disclosed annual percentage yield. For purposes herein, the “collected balance” is the balance of all deposits in your account, not including any items not yet paid or collected.

Balance Computation Method

Webster Bank uses the daily collected balance method to calculate the interest on your account. This method applies a daily periodic rate to the collected balance in the account each day of the statement cycle. For purposes herein, the “collected balance” is the balance of all deposits in your account, not including any items not yet paid or collected.

Accrual of Interest on Non-Cash Deposits

Webster Bank begins to accrue interest no later than the business day we receive credit for the deposit of non-cash items (for example, checks).

Fees

Standard service fees may apply. Standard service fees charged by Webster Bank are described in your Webster Bank Fee Schedule.

Withdrawal From Your Account

Webster Bank reserves the right to require not less than 7 days' notice in writing before any withdrawal from an interest-bearing account.

Transaction Limitations

Transaction limits on this account depend on your method of payment. There are transaction limits on withdrawals and transfers initiated by you and/or made through the Automated Clearing House (ACH) Network. These limits are designed to be flexible in order to protect you as well as the security and integrity of the service and accounts. Limits may be modified at our discretion without advance notice. Statements

As stated in the E-Sign Disclosure and Consent, you have consented to receive electronic statements. If you withdraw your consent to receive electronic statements, Webster Bank will have the right to close this account.

Account Closing by Webster Bank
